3. DECISION

4. PUBLIC SECTOR CLIMATE CHANGE DUTIES REPORTING 2016/17

In accordance with the delegation of authority approved by the Partnership at its meeting on 12 September 2017 (Report RTP/17/23 refers) there was submitted a report by the Senior Partnership Manager (Report RTP/17/30 refers) informing and updating members on progress on monitoring and annual reporting on the Partnership's carbon emissions and other activity reporting required under Public Sector Climate Change Duties, and seeking approval to remit to officers to complete the Public Sector Climate Change Reporting Template for 2016/17 for submission to the Sustainable Scotland Network by 30 November 2017.

Resolved:

- (i) To agree to note the report and the requirement to report on the Partnership's activities and policies in respect of Climate Change Duties; and
- (ii) To remit officers to complete and submit the Public Sector Climate Change Reporting Template for 2016/17 to the Sustainable Scotland Network by 30 November 2017.

5. CONSULTATIONS

In accordance with the delegation of authority approved by the Partnership at its meeting on 12 September 2017 (Report RTP/17/22 refers) there was submitted a report by the Director (Report RTP/17/31) seeking approval of responses to Scottish Government consultations on Free Bus Travel for Older and Disabled People and Modern Apprentices and on Building Scotland's Low Emission Zones.

After discussion it was agreed to amend the response to consultation on Free Bus Travel for Older and Disabled People and Modern Apprentices, as detailed at Annex C to Appendix A to the report, to explicitly state that Tactran does not support any reduction in the general utility of the concessionary travel scheme by any form of restriction on the current Scotland-wide and all-day travel availability of the concessionary scheme.

Resolved:

- (i) To approve the proposed response to Scottish Government's consultation on Free Bus Travel for Older and Disabled People and Modern Apprentices as detailed in Appendix A, with amendment to the response at Annex C as agreed; and
- (ii) To approve the proposed response to Scottish Government's Building Scotland's Low Emission Zones A Consultation, as detailed in Appendix B.
