The Tayside and Central Scotland Transport Partnership (Tactran) is one of seven statutory Regional Transport Partnerships established under the Transport (Scotland) Act 2005, with responsibility for developing and overseeing the delivery of a statutory Regional Transport Strategy. Tactran covers the areas of Angus, Dundee City, Perth & Kinross and Stirling Councils and is managed through a Partnership Board, comprising Councillors appointed by the four constituent Councils and non-Councillor members. The Partnership's Team, currently comprising 7 staff, is located in Bordeaux House, Kinnoull Street, Perth.

#### **JOB PURPOSE**

To support the development, implementation and monitoring of the Regional Transport Strategy, the Regional Transport Strategy Delivery Plan and associated Revenue and Capital delivery programmes with a particular emphasis on strategic interventions including road, rail, mobility hubs, freight and decarbonisation of transport and provide support to the Partnership's contribution to Development Planning, Community Planning and regional economic programmes including relevant City Deals.

The post reports to and works under the general direction and control of the Senior Strategy Officer.

#### MAIN DUTIES AND RESPONSIBILITIES

- 1. Supporting and contributing to the development, review, monitoring and implementation of the Regional Transport Strategy, including:
  - Supporting and contributing to development, monitoring and implementation of the Regional Transport Strategy Delivery Plan
  - Maintaining and supporting development of the Regional Transport Strategy Monitoring Framework and producing reports on this
- 2. Supporting and contributing to development, monitoring and implementation of associated Revenue and Capital programmes with particular focus on the strategic connectivity; buses; rail; mobility hubs and freight and decarbonisation of transport.
- 3. Developing, maintaining and utilising the Tay Cities Regional Transport Model, as required.
- 4. Assisting in the appraisal of proposals and projects in accordance with Scottish Transport Appraisal Guidance (STAG) and other relevant appraisal processes.

- 5. Supporting input to and the development and delivery of regional economic programmes including relevant City Deals.
- 6. Supporting regional input to national transport policy
- 7. Leading the procurement of consultancy support for studies, appraisals and other projects, as required.
- 8. Supporting the undertaking of and reporting on public and other consultations on Strategy and project development and delivery.
- 9. Supporting the operation and management of Regional Stakeholder Forums, including Freight Quality Partnership.
- 10. Liaising with Transport Scotland, Network Rail and Train Operating Companies on all Rail related matters within and beyond the region.
- 11. Investigating and supporting decarbonisation of transport, including assisting in the delivery of the Tactran Regional Electric Vehicle Strategy in conjunction with constituent Local Authorities.
- 12. Supporting regional input to Bus Alliances and Bus Service Improvement Partnerships.
- 13. Supporting input to Development Planning.
- 14. Supporting input to Community Planning and the delivery of local and national outcomes.
- 15. Analysing and contributing to responses to consultations on relevant policy and project delivery matters.
- 16. Producing and presenting reports to the Partnership Board and other forums.
- 17. Deputising for the Senior Strategy Officer.
